Do utilities use the Energy Commission's solar equipment lists?

Some utilities or local governments may use the Energy Commission's solar equipment lists during their interconnection or permit application processes. Note #1: PTC refers to PVUSA Test Conditions, which were developed to test and compare PV systems as part of the PVUSA (Photovoltaics for Utility Scale Applications) project.

How does the CEC support the interconnection portion of Rule 21?

The CEC supports the interconnection portion of Rule 21 by maintaining the Solar Equipment Lists and participating in Rule 21 working groups. Rule 21 is an electric tariff that describes the interconnection, operating and metering requirements for generation facilities to be connected to a utility's distribution system.

A disconnecting means shall be provided for all PV equipment. If the equipment is energized from more than one source, the disconnecting means shall be grouped and identified (CEC 690.15).
