What policy measures can support EV adoption in Greece?

Policy measures that could support EV adoption are provided. Electric vehicle proliferation is still at exceptionally low level in Greece. The subsidy program "I move electrically" aims to accelerate the transition to EVs providing incentives both for company and private electric vehicles.

How does financial incentives affect EV adoption in Greece?

Provision of financial incentives significantly affects users' acceptance of EVs. Environmental awareness and travel/demographic characteristics affect EV adoption. Policy measures that could support EV adoption are provided. Electric vehicle proliferation is still at exceptionally low level in Greece.

What is the EV program in Greece?

The Greek program "I move electrically" which was launched in the third quarter of 2020, and it will run until 2024, offers incentives for the promotion of EVs and charging stations. In line with the European standards (EEA/ACC/13/003), Greece subsidizes mainly private cars and light commercial vehicles.

How to promote EV sales in Greece?

Recommend a policy change for workplaces to install electric chargers in their parking lots. Maintain financial incentives in order to support increase of EV sales in the Greek market. Increase the marketing efforts to inform consumers about benefits of transitioning to electromobility and to provide information about changes in the marketplace.
