What does NDRC stand for?

On August 3, 2023, China's National Development and Reform Commission (NDRC), the Ministry of Finance (MoF), and the National Energy Administration (NEA) jointly issued the " Notice on Full Coverage of Renewable Energy Green Power Certificates to Promote Renewable Energy Electricity Consumption " (NDRC Document No. 1044) (" Document 1044 ").

How does the New Energy Directive affect new energy projects?

Under the new directive, all electricity generated by new energy projects--including wind and solar--must enter the power market, with grid tariffs determined by market transactions. A key aspect of the reform is the differentiation between existing and new projects.

What is a renewable power reform?

The reform focuses on three key aspects: allowing market forces to determine renewable power pricing, establishing a pricing and settlement mechanism that supports the long-term sustainability, and adopting differentiated policies for existing and new projects.
